2.1. Classification of the substance or mixture

8.2. Exposure controls**Appropriate engineering controls**

Ensure adequate ventilation, if possible with extractor fans at work posts and appropriate general extraction.
If the ventilation is insufficient to maintain the concentration of dust below the exposure limits, wear breathing apparatus.
Avoid dust production by broken fibres.

Violent reaction in contact with hydrofluoric acid, can give products of decomposition under the effect of temperature.

Amorphous silicate is transformed into crystalline silicate in the presence of alkali at about 800°C.

10.6. Hazardous decomposition products

Prolonged exposure to >1300°C causes the quartz to be transformed into cristobalite.

Upon exposure to temperature, the binder based on polyvinyl alcohol can be decomposed.

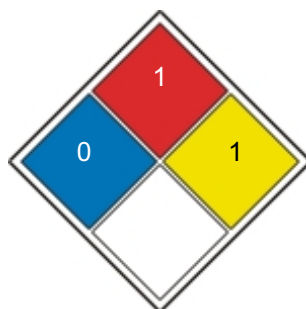
